Access to and use of the Society of Motion Picture and Television Engineers (SMPTE) “DPROVE” and/or “Digital Leader” D-Cinema Test Materials is subject to the following license terms:

The Test Materials were authored and developed by members of the SMPTE, and are the Copyrighted intellectual property of the Society of Motion Picture and Television Engineers (SMPTE). The DPROVE Test Materials consist of a set of encrypted D-Cinema Packages (DCPs) licensed for use on one or more D-Cinema servers and projectors.

Upon payment of the prevailing fee, SMPTE grants to user a non-exclusive, non-transferable, royalty-free, license to use any or all of the included DPROVE DCPs on the licensed servers, for a period of three years from grant of license. License may be renewed on payment of the prevailing fee.

The DPROVE Test Materials are licensed for use at a single location; and a key must be obtained for all servers at that location. User will advise SMPTE and purchase additional keys if additional servers are installed at the licensed location.

Additional terms for SMPTE Digital Leader:

The Digital Leader Test Materials include unencrypted image and sound files. User will store and protect the Digital Leader files with similar methodology and care as applied to other valuable copyright content entrusted to the facility. The files may be used only at a single location, and shall not be replicated except for backup, and as specified below:

Upon payment of the prevailing fee, SMPTE grants to user a non-exclusive, non-transferable, royalty-free, license, for a period of three years from grant of license, to incorporate any one set (specific frame rate, aspect ratio, resolution, 2D or 3D) of the included Digital Leader files as leader and/or foot leader into any DCDM reel prepared by the licensed facility, provided such DCDM contains substantial content other than the Digital Leader, and will be protected as described above, and distributed only in the form of an encrypted DCP. License may be renewed on payment of the prevailing fee. In the event of non-renewal user agrees to destroy immediately all copies of the licensed material.

Licensee shall not cause or permit and Digital Leader files or any instantiation or derivative thereof to leave the licensed premises, except under secure conditions to a trusted facility for the preparation of an encrypted DCP, or as leader/foot leader incorporated into an encrypted DCP.
